The Mayor and Rocky Mount City Council will consider appointments to the City's Boards, Commissions and Committees at an upcoming Committee of the Whole meeting. Applications will be accepted until May 15, 2021. Appointments are expected to be finalized by the City Council on July 12, 2021.

## Following is a list of appointments to be considered:

- Animal Care and Control Advisory Board five (5) appointments: Mayor, Wards 1, 2, 3 and 5;
- Board of Adjustment three (3) appointments: Wards 3 and 4; and Alternate Member;
- Business Development Authority two (2) appointments;
- Central City Revitalization Panel six (6) appointments: one (1) Central City Property Owner; one (1) Commercial Builder/Developer; two (2) Members-at-Large; and two (2) Ex-Officios;
- Community Appeals Board three (3) appointments: Wards 3, 4 and 6;
- Historic Preservation Commission three (3) appointments;
- Housing Authority three (3) appointments: two (2) members and one (1) public housing member;
- Human Relations Commission one (1) Mayoral appointment; four (4) City Council appointments;
- Martin Luther King, Jr. Commission four (4) appointments:
- Mayor's Commission on Persons with Disabilities five (5) appointments;
- Planning Board three (3) appointments: Wards 1, 3 and 5;
- Redevelopment Commission three (3) appointments;
- Transportation Advisory Committee three (3) appointments (Councilmembers);
- Tree Advisory Board three (3) appointments Wards 2, 3 and 4;
- Utility Service Review Board four (4) appointments: Wards 1, 3, 4 and 5; and
- Workforce Housing Advisory Commission six (6) appointments: Wards 3, 4 and 5, one (1) Faith-based Community member, one (1) Housing Developer member and one (1) Business Community member.

The individuals presently serving on these various boards whose terms are expiring are eligible for reappointment and may be considered by the Mayor and City Council in the appointment process along with any other applicants.
