5. **Question:** Will it be the contractor's responsibility to remove existing underbrush growing in the cemetery areas that have not been cleaned?

Answer: Yes, the contractor will be responsible for removing existing underbrush growing in the cemetery areas that have not been cleared.

6. **Question:** Will it be the contractor's responsibility to remove underbrush that has been cut and laying on the ground in a big portion of the cemetery?

Answer: Yes, it will be the contractor's responsibility to remove underbrush that has been cut and laying on the ground in big portion of the cemetery.

7. **Question:** Will it be the contractor's responsibility to remove all waste that has been pruned and left along the road from volunteer workers or family members of gravesites?

Answer: Yes, it will be the contractor's responsibility to remove all waste that has been pruned and left along the road from volunteer workers or family members gravesites.

- 8. **Question:** Does the City want winter rye planted in areas that you will be able to mow? **Answer:** Yes, we would like winter rye planted in all common areas.
- 9. **Question:** Does pricing need to be done on the cemetery as a whole or does it need to be done in sections as volunteers or contractors complete clean up in each area? If so, can pricing sheet be revised to reflect?

Answer: Yes, we would like the contractor to contact the proper people to perform the work in the riparian zone. The contractor will also make sure to include city representatives in all conversations as it relates to work in the riparian zones.

12. **Question:** There is a lot of unfinished work, such as: stump grinding, tree removal, and sunken graves, will the pricing for that need to be included in the proposal?

Answer: Pricing should include unfinished work such as stump grinding, small tree removal (less than 4 inches in diameter) etc. Sunken graves, monument repairs are not included in this contract.

Current Conditions:

Unity Cemetery encompasses approximately 16 acres of gently sloping terrain. The lot is an irregular shaped parcel. Neighboring properties include Grande Avenue and Northeastern Cemetery. Cowlick Creek runs through the back of the property. The cemetery site consists of a mixture of pine and oak trees. Volunteer groups have begun clearing areas in section A. This has left a lot of tree stumps that will require grinding and/or removal.

Unity Cemetery has direct access from Grande Avenue and is located approximately 1 mile west of US 64. Unity Cemetery has gravel roads and an entrance sign.

Unity Cemetery Potential Hazards

- Sunken graves
- Broken headstones
- Sunken foot markers
- Dead trees
- Low level tree branches
- Curbs partly hidden by grass.
- Roots of trees penetrating walkways.
- Leaning or propping up against a headstone
- Hidden dangers such as rat urine on stonework, weeds, and grasses
- Slippery paths especially after periods of heavy rain
- Hypodermics or drug equipment discarded in the area.
- Bottles or broken glass
- Illegal dumping
- Infections via cuts or grazing
- Monument collapse and cave ins
- Hazardous atmospheres: Potential hazardous gas
- Risk exposure to falls and trip hazards
